APPLICATIONS:

- Conditions serpentine and V-belts for prolonged belt life

DIRECTIONS: 1. Keep hands away from moving belts and shut motor off before use. Determine if belt tension meets manufacturer's recommended specifications. Examine belt for deterioration, cracks or worn surfaces. If the belt needs adjustment or replacement, take the proper steps to correct. 2. Hold can upright about 12 inches from belt and spray small amount on underside of belt just before the pulley. Use extension tube for hard to reach places. Wipe excess. Allow belt to run for several minutes to distribute product evenly. 3. Repeat every 3 months or 3000 miles to help keep rubber soft and flexible. If belt still squeaks, further adjustment or replacement is necessary. IMPORTANT: Pretest painted, varnished, lacquered or plastic surfaces. Flush surface with water after testing.

STORAGE, HANDLING & DISPOSAL: Store in a dry, well-ventilated area below 120°F/49°C. Do not expose to heat, spark, or open flame. Do not puncture or incinerate can. Dispose of product, container and residue in accordance with all local, state and federal laws and regulations.
